OFFSHORE LICENSE REGISTRATION

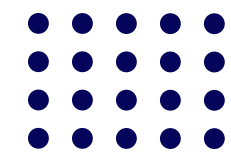

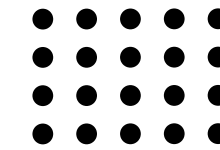
We register offshore companies with UAE offshore jurisdictions, namely RAK ICC, JAFZA.

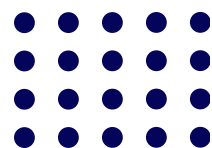

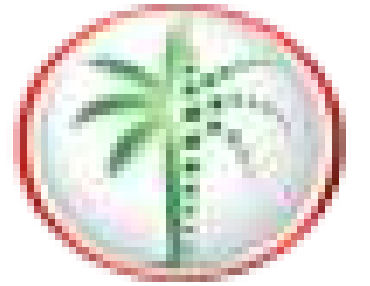

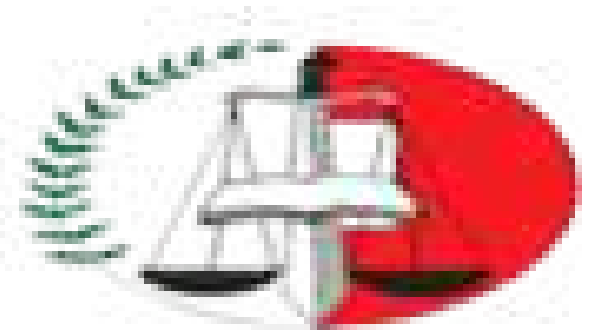
